- An application fee of \$150.00 must accompany all applications made payable to the Lake Wylie Marine Commission. The application fee will be refunded if the application is disapproved by the LWMC or North Carolina Wildlife Resources Commission or the South Carolina Department of Natural Resources.
- The No Wake Buoy(s) must be installed by an approved LWMC Contractor and paid for by the Applicant.
- This completed hardcopy application, \$150.00 check, and accompanying documentation must be received 10 business days prior to a regularly scheduled meeting of the Lake Wylie Marine Commission to be considered at that meeting.
